Today's Guest Speaker Jennifer D. Dobbs

Executive Director Arts Bridge Foundation

Jennifer D. Dobbs is the executive director for the ArtsBridge Foundation at the Cobb Energy Performing Arts Centre.

Since her arrival in May of 2017, Dobbs has increased revenue, inaugurated new programs, created new partnerships, conducted the first environmental scan and full strategic plan, revived various committees to assist with programming, hired and developed a new ArtsBridge team, expanded and diversified the Board, and much more. In recognition of her efforts, Dobbs received the 2019 liveSAFE Resources Tribute to Achievement, naming her to the organization's Academy of Women Leaders.

Dobbs hopes to continue outreach expansion at ArtsBridge and encourages businesses, organizations, foundations, and individuals to become invested partners.

Previously, Dobbs was the executive director of the Alonzo F. and Norris B. Herndon Foundation in Atlanta starting in 2015. Prior to that Dobbs was the director of development for the Center for Ethics at Emory University, where she raised funds for an inaugural international summit.

Before moving to Georgia from Pennsylvania, Dobbs' previous positions included director of development for the nationally-recognized Erie Art Museum; adjunct English faculty for Mercyhurst University at its inner-city Booker T. Washington Center satellite location; Leadership Giving Coordinator for United Way of Erie County, where she inaugurated a new women's leadership initiative, Women In Action; Target Area Local Leaders (TALL) Team Coordinator of the City of Erie's Weed and Seed Program, where she coordinated residential

participation in helping to eliminate problems in the city's most impoverished areas; and higher education administration at Gannon University and LaRoche College.

Dobbs graduated in 1999 with a bachelor's degree in English with a concentration in writing from Edinboro University of Pennsylvania. She is a 2001 graduate of United Way of Erie County's Project Blueprint minority leadership development program. She was named a 2001-2002 Jupiter Fellow through the Clarence J. Jupiter Fellowship for Minority Professionals at the Council for Advancement and Support of Education (CASE), a program that trained her in institutional advancement. In August 2003, she earned a master's degree in public administration with a concentration in organizational leadership from Gannon University in Erie, Pa. In 2008 Dobbs completed her international Resident Fellowship program with United Way of America (now United Way Worldwide), which trained her to be a CEO by developing her professional and personal skills. Currently, Dobbs is a doctoral candidate at Walden University studying public policy and administration with a specialty in policy analysis.

Dobbs was a charter member and the inaugural chair of the Erie County Gaming Revenue Authority (ECGRA), established in 2008, where she assisted in the distribution of over \$20 million into the community for economic development purposes. Dobbs is a member of The Pennsylvania Society which honors achievement, rewards excellence, promotes good will and understanding and celebrates service to humanity in general. She is a devoted mother to three children, Xavier, Roman, and Isis, and a proud grandmother to twins, Presley Rose and Peyton Lily.

On a sad note, President Jesse announced the passing of **Barbara Shaw**, Rotary Club of Marietta member who joined our Club June 10, 1988.

Announcements included an invitation to attend a Rotary District social at Hoyle's, April 18, Easter sunrise service at Kennesaw Mountain National Battlefield, and Memorial Day 5K race May 25.

Today's program speaker, Ron Sifen was introduced by Past President **Fred Beloin**. Ron is a knowledgeable source of community issues especially related to traffic and transportation in the metropolitan Atlanta region. A graduate of Washington University, his topic was Improvements in Mobility.

The recently completed managed traffic lanes (toll lanes) on I-75 and I-575 cost \$835million. This cost was borne approximately 1/3 equally through Federal grants, State of Georgia and a private partnership. Drivers using these roadways are benefiting by average daily speeds of 50MPH on managed lanes and 30MPH on the traditional or unmanaged traffic lanes.


Future transportation infrastructure construction plans with completion scheduled for 2028 include managed lanes on GA 400, and through the middle of I-285 stretching around the northern arc from I-20 West to I-20 East. Further interstate road construction over the next 9 years includes replacement of the I-20 East and West interchanges.


