# 08/23/2024 Vinings Cumberland Rotary Board Meeting Minutes

Friday, August 23, 2024

In Attendance: Shawn Bendig, Brant Campbell, Jolene Northrop, Annie Roberts, Ann Hudgins, Casey Patrick, Todd Ash, Fiona Grandowski

Meeting called to order by President Shawn Bendig.

Approval of minutes from June Board Meeting with one correction, 53 members instead of 54 – Approved - Unanimous approval

Board Retreat Meeting minutes – Approved – 7 approvals, 1 abstention

# Budget

- \$35k available for projects
- Charity acct. 15k rolling over from Matt's year for the Agua Fresca Global Grant. Transfer of \$8.2k from last year's race. \$25K is 5% of the investment account. On 5/31/2024, 5% balance is what we use for local and international projects. This value is not set in stone each year, sometimes we take in more sometimes less.
- Charity budget is approximately \$50k, 15k for the Global Grant, so 35k available for international and local projects.
- \$15k for website, fees, admin, SoS registration.
- \$70k dues income for the year
- \$7.3 K for social
- \$89K total was our income for Matt's year, less expenses of 71k, resulting in net income just over 18k. This was very good since we were devoid of income for several years through covid. This should increase each year and especially will new members.
- We have used about \$4k of Shawn's budget this Rotary year [started July 1].
- Question raised regarding DACDB, question of if this is still needed. Jolene does not recall exactly if this is related to any of the district site requirements. Action: Shawn will reach out to Alec Smythe about this and the possibility to decommission/sunset DACDB to gain cost savings.

#### Race Update

- Jolene working with Bill on transition of race leadership
- Runner who did not receive a time, Jolene working with Bill to resolve issue from race day
- No longer saving awards.
- Next year we have 4 way test posted at the finish line
- Rough race numbers, 4/1 through 8/23. We collected \$57.5k from sponsors and received a few more thousand of checks from club members. Member sponsors are

\$61K and Charles Heinz memorial is \$2k. Total \$119K. \$33.7k sent so far for expenses and Skip has not been paid at this point which was \$12k expense last year. Probably \$45K will be the cost this year which is more than last year. The costs may be below the race registrations as per Jolene, so this would be a great improvement in that the remainder of sponsorships would be additional income. Report from website needed. Jolene following up.

- \$2.5k for table on Delk www.tableondelk.com . Table in Delk is a DISTRICT PROJECT WHICH WE MATCH IF AWARDED so we match if we receive it or just donate our \$2,500. Shawn and Dave visited last week and it is impressive all of the good work. Maybe we can have them come back and speak to us/be our program and also advise where we can volunteer to help.
- Cobb Rotary social tonight Free admission and quite a few VCR members are going to be in attendance. Great opportunity to engage with other Cobb Rotary members.

## International

- Brant provided an update regarding the Global Grant. Rotary International requested additional detail regarding the Agua Fresca project and its Global Grant. Brant and the Luque Rotary club members have met and also met with the club in Nueva Italia regarding the remaining detail requested. Action: Brant will compile the detail

requested for the Global Grant submission and provide to Rotary International, Diane Lopez.

- Casey updated that the first meeting of this school year will be next Wednesday. Betty proposed a joint project with the facility at the bike organization.

#### RYLA

- Communication will start being received in January as per Todd. Todd will continue to lead in the area of RYLA.
